SA Exposure Locations

Rapid Antigen Test Kits

The use of over the counter COVID-19 Rapid Antigen Test (RAT) kits is currently prohibited in South Australia. These tests are much more likely to miss cases of COVID-19 than oral and nasal swab PCR testing, particularly when there are low levels of COVID-19 in the community.

Use of RAT in South Australia will be introduced when there is spread of COVID-19 in the community. At all times, people with symptoms, even if mild, need to get a PCR test at a pathology site, not use a RAT.

Clarification of the <u>COVID Exposures in Primary and Community Health Care Settings Risk</u> <u>Matrix</u>

- <u>Fit checking vs fit testing</u> Fit checking of Particulate Filter Respirators (PFRs) is required for exposure assessment. Fit testing is recommended but not required to determine if someone meets the close contact criteria.
- <u>Definition of vaccinated and unvaccinated contact</u> Vaccinated/Unvaccinated contact refers to the person who has been exposed (i.e., in the primary care matrix this is referring to the staff member or patient who has been exposed to someone with COVID-19). Case refers to the person who has tested positive for COVID-19. The vaccination status of the person who already has COVID-19 is irrelevant to the exposure assessment process and will not impact on quarantine and testing requirement for someone who has had contact with the person with COVID-19.
- Length of wear for PFRs: Advice from the SA Health COVID-19 Infection Control Services Team

The current advice as per the Department of Health's Infection Control Expert Group's <u>use of face masks and respirators in the context of COVID-19 fact</u> <u>sheet</u> states that you can use a PFR continuously for a single session of care. If removed (e.g., for a meal break or drink), it should be discarded and replaced with a new one. A correctly fitted PFR (i.e., with adequate face-seal), often becomes uncomfortable with prolonged use. Prolonged use can cause headache, thermal stress, painful pressure on the bridge of the nose and/or adverse respiratory and dermatological effects. If any of these occur the wearer is more likely to unconsciously loosen or adjust it and risk contaminating their hands and face or be noncompliant with its use. A mask/PFR should also be changed it if becomes soiled, moist, or damaged.

• <u>Clarification on eye protection</u> Acceptable eye protection includes face shields, closely fitted wrap-around goggles or safety glasses. Prescription glasses that do not provide side protection from droplets are not considered eye protection.

Vaccination Exemptions

COVID-19 vaccination exemptions are limited to those with a medical certificate or letter from a legally qualified medical practitioner certifying that the person:

- Has a medical exemption from receiving a TGA approved COVID-19 vaccine on either a permanent or temporary basis in accordance with the guidelines published by ATAGI; or
- Has a medical exemption on either a permanent or temporary basis from receiving the preferred vaccine as recommended by ATAGI for the person's age; or

- Has an appointment to be assessed by a medical specialist or has commenced an assessment with a medical specialist to determine whether they have a medical exemption from receiving a COVID-19 vaccine on either a permanent or temporary basis in accordance with the guidelines published by ATAGI; or
- Is currently taking part in a COVID-19 vaccine trial that has regulatory approval and a confirmed start date for participation and receipt of a TGA approved vaccine would impact the validity of the trial.

The certificate or letter must clearly outline the reason for the exemption and which direction applies to their employment. The Chief Public Health Officer or her delegate must endorse the exemption. Medical practitioners must complete an <u>SA Health Chief Public Health Officer</u> <u>Immunisation Exemption Application Form</u> and the completed form and medical certificate must be submitted to <u>Health.NJNPExemptions@sa.gov.au</u>.

COVID-19 Testing Prior to Elective Surgery

From 1 December 2021, patients who present to SA Health sites for elective surgery should receive a COVID-19 test in the preceding 72 hours prior to attending and 48 hours prior for paediatric elective surgery patients.

There is a significant increase in risk of illness or death for patients undergoing elective surgery who are COVID-positive. Surgery is also associated with aerosol generating procedures which can put healthcare workers at an increased risk of catching the disease themselves.

Making sure patients are COVID-negative prior to elective surgery will ensure they are minimising the risks to themselves and to the staff taking care of them.

Visiting Public Hospitals

From 7 December 2021, there are new visitor guidelines for public hospital and health care services. All visitors must provide proof of COVID-19 vaccination upon entry, wear masks and not attend if they have been unwell in the past 72 hours. Unvaccinated visitors must wear PPE during their visit and undertake a COVID-19 test 48 hours after their visit.
